Sir,

I am directed to refer to your communication dated 31/10/2020 in the subject cited addressed to the Minister of Social Justice & Empowerment and subsequently redirected to this Ministry.

2. As per the draft list of Denotified Tribes, Nomadic Tribes and Semi Nomadic Tribes of India published by National Commission for Denotified, Nomadic and Semi Nomadic Tribes, Ministry of Social Justice and Empowerment; "Poosala" tribe is listed at Sl. No. 53 in the list of Nomadic Tribe of Andhra Pradesh.

3. The Government of India on 15.6.1999, and further amended on 25.6.2002, has approved the modalities for deciding the claims for inclusion in, exclusion from and other modifications in the Orders specifying lists of Scheduled Tribes. According to these modalities, only those proposals which have been recommended and justified by the State Government/UT

Administration concerned, can be processed further. Thereafter, it has to be concurred with by the Registrar General of India (RGI) and the National Commission for Scheduled Tribes (NCST) for consideration for amendment of legislation. As per extant modalities, recommendation of the concerned State Government is a pre-requisite for processing any proposal for inclusion in the list of Scheduled Tribes of the State.




