

Arabolu Chandrasekhar, State President, 92-11-703, Sriram Nagar, A. T. Agraharam, Gurntur City 522004. A.P. on the subject mentioned above.


2. According to the draft list of Denotified Tribes, Nomadic Tribes and Semi Nomadic Tribes of India published by National Commission for Denotified, Nomadic and Semi Nomadic Tribes, Ministry of Social Justice and Empowerment; "Poosala" tribe is listed at Sl. No. 53 in the list of Nomadic Tribe of Andhra Pradesh.
3. The Government of India on 15.6.1999, and further amended on 25.6.2002, has approved the modalities for deciding the claims for inclusion, exclusion and other modifications in the Orders specifying lists of Scheduled Tribes. According to these modalities, only those proposals which have been recommended and justified by the State Government/UT Administration concerned, can be processed further.

Thereafter, it has to be concurred with the Registrar General of India (RGI) and the National Commission for Scheduled Tribes (NCST) for consideration for amendment in the legislation.

4. This Ministry has not received any proposal for inclusion of "Poosala" Community in the ST list of Andhra Pradesh. As per extant modalities, the recommendation of the concerned State Government is a pre-requisite for processing proposal for inclusion of any community in the list of Scheduled Tribes of the State.
